**5.1 Extinguishing media:**

Product is non-flammable under normal conditions of storage, handling and use. 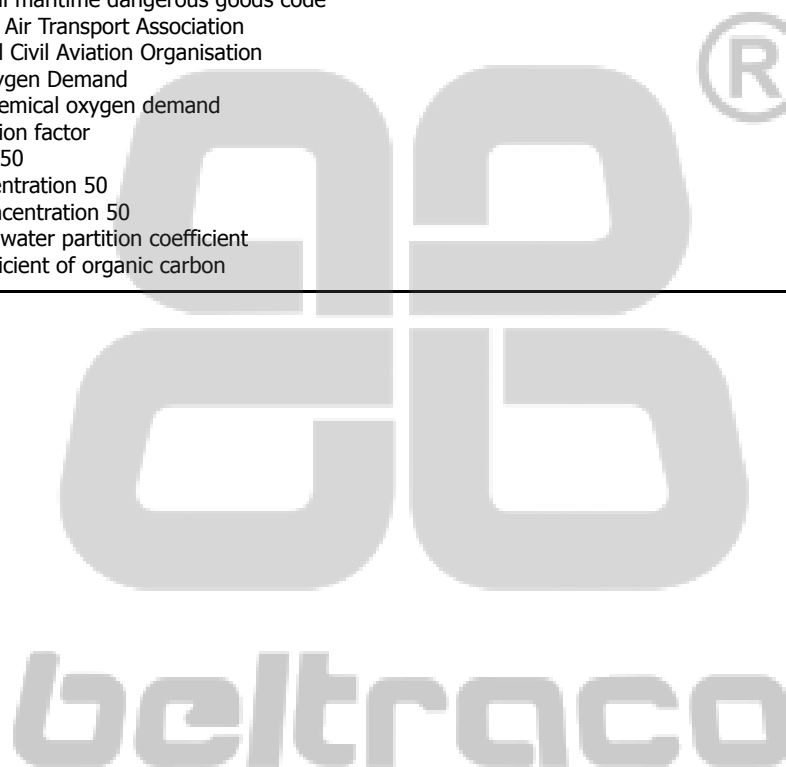
